## **1. Technical Work Group Ballot Background**

The CAQH CORE Prior Authorization Subgroup (PASG) launched in Q4 2017 to develop potential draft operating rules that build on the foundational infrastructure requirements established by the [Phase IV CAQH CORE 452 Health Care Services Review – Request for Review and Response \(278\) Infrastructure Rule](#), and move the needle closer to a more efficient prior authorization (PA) process.

In Q3 2018, the CAQH CORE Rules Work Group (RWG) launched to review the rules drafted by the PASG to continue development and refinement of the draft operating rules for the prior authorization process.

The following Draft Phase V Prior Authorization Operating Rules were approved by the Rules Work Group:

- Phase V CAQH CORE Prior Authorization (278) Request / Response Data Content Rule.
- Phase V CAQH CORE Prior Authorization Web Portal Rule.

Beginning in Q4 2018, the CAQH CORE Certification & Testing Subgroup (CTSG) launched to develop a test suite for the Draft Phase V CAQH CORE Prior Authorization Operating Rules. The rules were reviewed by CTSG participating organizations during the three calls held and were given a chance to provide feedback on each section of the test suite through straw poll. Based on feedback received during the straw poll process and follow-up subgroup discussion, the CAQH CORE Certification & Testing Subgroup reached agreement on an updated Draft Phase V CAQH CORE Certification Test Suite to forward to the Technical Work Group.

The CAQH CORE Technical Work Group (TWG) launched in Q1 2019 to review the Draft Phase V CAQH CORE Certification Test Suite. Upon reviewing the draft test suite, the TWG agreed to move the draft test suite forward to a formal Technical Work Group Ballot. The ballot was sent to the TWG on 02/06/2019 and closed 02/27/2019. Results were sent to the TWG via email on 02/28/2019. This document (posted to the CAQH CORE Calendar on 03/05/2019) contains the results of the ballot, as well as the deidentified comments submitted by responding organizations.

## 2. Technical Work Group Ballot Results

Per the CAQH CORE Voting Process, the following must occur at the Work Group level for approval of the Draft Phase V CAQH CORE Certification Test Suite:

- **Quorum Required for Ballot:** 60% of the Work Group.
- **Approval Required for Ballot:** Simple majority vote (50%)
