CAQH CORE Value-based Payments (VBP) Initiative	<ul style="list-style-type: none"> • Ms. Weber (CAQH CORE Director) started the call with a brief history of CAQH CORE, the current make-up of participating organizations and the CAQH CORE mission and vision (Slide 4-5). • Ms. Weber (CAQH CORE) reviewed CORE's prior work on Value-based Payments (Slides 6 – 11). • Ms. Weber (CAQH CORE) then turned it over to Troy Smith to discuss the work of the Advisory Group and how they decided on provider attribution as a focus. 	<i>Discussion</i>
4. CAQH CORE Value-based Payment Advisory Group	<ul style="list-style-type: none"> • Troy Smith (BCBSNC) reviewed the work of the Value-based Payment Advisory Group. He then discussed the top opportunity areas that the Advisory Group started with and why they decided on provider attribution as the focus for the subgroup (Slides 12-16). • Mr. Smith (BCBSNC) then turned the call over to April Todd (CAQH CORE). 	<i>Discussion</i>
5. Value-based Payment Subgroup Opportunity Area Focus: Patient/ Provider Attribution	<ul style="list-style-type: none"> • Ms. Todd (CAQH CORE) introduced herself as SVP of CAQH CORE and Explorations and reviewed the opportunities for the subgroup to pursue around operating rules for provider attribution, these included opportunities in data content, infrastructure and connectivity. (Slides 17-23). • Ms. Todd (CAQH CORE) then turned the call over to Ms. Weber (CAQH CORE) to go over next steps. 	<i>Discussion</i>
6. Next Steps for VBP Subgroup	<ul style="list-style-type: none"> • Ms. Weber (CAQH CORE) walked the group through the rolls and expectations of VBP Subgroup Participants and CAQH CORE Staff. She encouraged the group to review the resources CAQH CORE has online for VBP. She also encouraged organizations to refer others SME's that they work with to the workgroup. • Ms. Weber (CAQH CORE) described the VBP Subgroup Feedback Submission form that would be distributed the day after the call and explained that it would be due on October 30th. • Ms. Weber (CAQH CORE) then turned the call over to questions.
