# CAQH CORE Review Work Group Ballot – Draft CAQH CORE Attachments Operating Rule Packages, Draft CAQH CORE Eligibility & Benefit Data Content Rule Update, CAQH CORE Infrastructure Rules Update

#### Ballot Purpose & Overview

This Ballot allows each CAQH CORE Review Work Group (RWG) Participating Organization to indicate whether they support the draft rules and rule requirements being balloted or not. Per the <u>CAQH CORE Voting Process</u>, the following must occur at the Work Group level for approval of the each of the items under consideration:

- Quorum Required for Ballot: 60% of the Work Group.
- Approval Required for Ballot: Simple majority vote (50%).

CAQH CORE RWG approval is required before the Final CAQH CORE Vote. If the draft rules meet the required quorum and approval levels, the results of the RWG Ballot will be shared with RWG Participating Organizations via email following the end of the RWG Ballot submission period.

#### Additional Background

The RWG launched in August 2021 to review, refine, and approve *Draft CAQH CORE Attachments Operating Rules* for prior authorization and claims, updated *CAQH CORE Eligibility & Benefits Data Content Rule*, and identify areas of support to update the existing *CAQH CORE Infrastructure Operating Rules*.

The RWG completed two straw polls that measured the level of support for each of the four items being balloted. The straw polls provided insight into the RWG Participating Organizations' level of support and informed the refinement of each rule, rule requirement, and test scenario under consideration. Adjustments were made in accordance with the RWG straw poll findings and discussions. As a next step, the RWG will review final adjustments via the formal RWG Ballot.

# Updates to CAQH CORE Infrastructure Operating Rules - System Availability Requirements

Please review the draft substantive updates to the system availability requirement language highlighted in grey text below. This language is updated in each CAQH CORE Infrastructure Operating Rule.

### 4.3.1. System Availability Requirements

### 4.3.1.1. Weekly System Availability Requirement

System availability must be no less than <u>86</u> 90 percent per calendar week for both Real Time and Batch Processing Modes. System is defined as all necessary components required to process a 5010X217 278 Request and Response and a 5010X231 999 transaction. Calendar week is defined as 12:01 a.m. Sunday to 12:00 a.m. the following Sunday. This will allow for a HIPAA-covered health plan or its agent to schedule system updates to take place within a maximum of <u>24</u> 17 hours per calendar week for regularly scheduled downtime.

### 4.3.1.2. Quarterly System Availability Requirement

A HIPAA-covered health plan or its agent may choose to use an additional 24 hours of scheduled system downtime per calendar quarter. System is defined as all necessary components required to process a 5010X217 278 Request and Response and a 5010X231 999 transaction. This will allow a HIPAA-covered health plan or its agent to schedule additional downtime for substantive system migration. This addition allowance in system downtime is in excess of the allowable weekly system downtime specificied in Section 4.3.1.1.

As a reminder, the draft updates to the CAQH CORE Infrastructure Rules include substantive updates the system availability requirements and non-substantive updates to the existing CORE Connectivity and Companion Guide references; however only substantive adjustments are being formally voted on in this Ballot.
